CERTIFIED PAYROLL REPORTING

Contractors and subcontractors on most public works projects are required to furnish certified payroll records (CPRs) to the Labor Commissioner, using DIR's new electronic payroll reporting (eCPR) system.

Enforcement of this requirement is on hold but the eCPR system continues in operation. The DIR strongly encourages contractors and subcontractors to continue using the system while upgrades are in progress. Please refer to the attached bulletin issued by the DIR.

During World War II, there was an increased need for skilled administrative personnel, particularly in the United States. The National Secretaries Association was formed to recognize the contributions of secretaries and other administrative personnel to the economy, to

The association's name was changed to Professional Secretaries International in 1981 finally. and. International Association of Administrative Professionals (IAAP) in 1998.

These changes in name reflected the changing nature of the tasks, qualifications and responsibilities of the members of the organization. IAAP now has international orientation and continues to provide education and training and set standards of excellence recognized by the business community on a global perspective. The organization's vision is "to and eauip administrative professionals to attain excellence".

The first National Secretaries Week was organized in 1952 conjunction with United States Department of Commerce and various office supply and equipment manufacturers. Wednesday of that week became known as National Secretaries Day. As the organization gained international recognition, the events became known as Professional Secretaries Professional Week® and Secretaries Day®. In 2000, IAAP announced that names of the week and the day were changed Administrative Professionals

Administrative Week and Professionals Day to keep pace with changing job titles expanding responsibilities of the modern administrative workforce. Many work environments across the world observe this event.

TEAMSTERS LOCAL PESION SEEKS BENEFIT CUTS

A New Jersey based Teamsters local pension fund has become the third multiemployer pension plan know to apply for Treasury Department approval of benefit suspensions.

In separate notices issued January 26, Treasury indicated that the Teamsters Local 469 Pension Plan in Hazlet, NJ has joined the Iron Workers Local 17

Pension Fun in Cleveland and the Central States. and Southeast Southwest Areas Pension Fund seeking to use provisions of 2014 federal law designed to financially troubled multiemployer plans avert future insolvency by suspending the accrued benefits of plan participants.

The notices were published in the January 27 Federal Register.

Thirty-nine employers were part of the Teamsters Local 460 plan in 2014, and it included 1,781 total participants, only 128 of whom were active, the plan said in its 2014 Form 5500 filing. Current assets were \$122.6 million and liabilities were \$279.9 million, the local reported.

The Teamsters fund filed its petition December 28, five days after the Iron Workers filed theirs, although the latter application wasn't received by Treasury until December 28, the department said.

Treasury has 225 days to reject each application.

The massive Central States fund became the first multiemployer plan to file for rescue under the Multiemployer Pension Reform Act, when it filed its application with Treasury in September.

Karen Friedman. Executive Vice President of the Pension Rights Center in Washington, told Bloomberg BNA that although she hasn't yet seen the filing by the Teamsters Fund, "this goes to show that plan after plan is now going to cut their retirees benefits to balance their books." She said "this is completely unfair" and that there needs to be a "better solution to address underfunded multiemployer plans."

Friedman added that "Congress will rue the day" that it supported the MPRA.

The Teamsters fund's Business Manager declined to comment to Bloomberg on the filing.




FLUKE METER CLASS


