LABOR RATE INCREASE

Just a reminder that there was an increase to the wage package in Local #234 based on the previously negotiated agreement. Labor Bulletins were distributed previously and can be accessed on the chapter's private website at www.mbccneca.org.

IBEW LOCAL #332 WITHDRAWS FROM REGIONAL PORTABILITY MOU

Effective December 4, 2016, IBEW Local #332 withdraw from the regional portability Memorandum of Understanding between Local 302, 595 and 332. See formal notification for details.

EARLIER DEADLINE FOR EMPLOYER W-2 AND 1099 MISC FILING

In an effort to reduce fraud, a provision in the Consolidated Appropriations Act passed by Congress has changed the filing deadlines for employer copies of W-2 and 1099 MISC. Effective for the tax year 2016, the deadline for filing W-2's to the Social Security Administration and 1099-MISC to the Internal Revenue Service will be January 31st of the following year (rather than February 28th as it was in the past). The new deadline includes electronic and paper W-2/1099 MISC returns.

The 2016 employer W-2/1099 MISC filing deadline is Tuesday, January 31, 2017. The following deadlines are not changing for the 2016 tax year:

- Distribute forms W-2/1099 MISC to employees by January 31, 2017
- Since the tax filing • deadline of April 15, 2017 falls on а Saturday, personal income tax returns be filed must by Monday. April 17, 2017

IRS MILEAGE RATES

IRS Mileage Rates for 2017 On December 13, 2016, the IRS issued the 2017 optional standard mileage rates used to calculate the deductible costs of operating an automobile for business, charitable, medical or moving purposes. Beginning January 1, 2017, the standard mileage rates for the use of a car (also vans, pickups, and panel trucks) is \$0.535 per mile (down from \$0.54 in 2016).



On 11/22/2016, U.S. District Judge Amos Mazzant issued a nationwide injunction that blocked implementation of the new federal salarv standard for employees to qualify as exempt under the salary basis test. This means that employers do not have to pay exempt employees a minimum salary of \$47,476 as of December 1 to retain exempt status. For more information, click here.

LADDER SAFETY

How to Choose a Ladder Most fatal falls in the workplace are from ladders. Choosing the correct ladder for your work tasks is an important part of your ladder safety program that should include training, proper maintenance and storage,

inspections, and safe work procedures. First, assess the height of your work task. Stepstools and short ladders elevate you slightly. Stepladders and extension ladders can get you to further heights. What type of work will you be doing? Is the ladder used to enter and exit a work area, or will you be working from it? Platform ladders and work platforms provide stable, elevated working surfaces. Is there an unusual space or access issue? Specialty tripod or trestle ladders access awkward spots. Determine the rated capacity you need. Office and household ladders are not suitable for construction and heavy-duty work. Choose a ladder that can hold the weight of the worker and the load of materials or tools that they will carry up and down. Type 1A ladders are rated for 300 pounds while 1AA ladders hold 375 pounds. Exceeding the weight capacity of a ladder can cause it to buckle, twist, and collapse. Your ladder material is important. Fiberglass ladders are sturdy, non-corrosive, and nonconductive if clean and dry, so use them for working around electricity. Aluminum ladders are lightweight and durable, but should NOT be used around electricity. What accessories do you need? Stabilizing bars can hold extension ladders in place when you access rooftops. Travs hold tools and

materials. Specialty footings or levelers provide stability on unusual or uneven surfaces. Consult ladder vour manufacturer about compatible accessories and how to use them properly. You may need several ladder types and sizes for your job tasks. Know how to store, transport, and access your safelv ladders and conveniently. Ladder handles or wheel devices help you conveniently manage and move your ladders. Step up to safety on the proper ladder for the job!
